A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED, BY ADDING PROJECT NO. 29-478, ENTITLED "HARDY ELEMENTARY SCHOOL/PARK IMPROVEMENTS," TO THE FISCAL YEAR 1981 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING THE EXPENDITURE OF \$2,230 FROM PSD 11610; \$14,228 FROM PSD 11611; \$616 FROM PSD 11613; \$15,526 FROM PSD 11614; \$12,007 FROM PSD 11615; \$3,205 FROM PSD 15600; \$11,815 FROM PSD 15611; \$35,040 FROM PSD 15630 AND \$5,333 FROM PSD 15631 FOR THE PURPOSE OF CONSTRUCTING IMPROVEMENTS AT HARDY ELEMENTARY SCHOOL; AND REQUESTING THE SAN DIEGO UNIFIED SCHOOL DISTRICT TO ENTER INTO A CONTRACT FOR THIS PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 2, subsection 29 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 00-15298-1, as amended, be and the same is hereby further amended by adding CIP Project No. 29-478, Hardy Elementary School/Park Improvements, to the fiscal year 1981 C.I.P. Program.

2. That the expenditure of \$2,230 from PSD 11610; \$14,228 from PSD 11611; \$616 from PSD 11613; \$15,526 from PSD 11614; \$12,007 from PSD 11615; \$3,205 from PSD 15600; \$11,815 from PSD 15611; \$35,040 from PSD 15630 and \$5,333 from PSD 15631 for the purpose of constructing improvements at Hardy Elementary School is hereby approved.

3. That the San Diego Unified School District is hereby requested to enter into a contract for the construction of improvements at the Hardy Elementary School.
