That the expenditure of \$2,230 from PSD 11610; \$14,228 from PSD 11611; \$616 from PSD 11613; \$15,526 from PSD 11614; \$12,007 from PSD 11615; \$3,205 from PSD 15600; \$11,815 from PSD 15611; \$35,040 from PSD 15630 and \$5,333 from PSD 15631 for the purpose of constructing improvements at Hardy Elementary School is hereby approved.
- 3. That the San Diego Unified School District is hereby requested to enter into a contract for the construction of improvements at the Hardy Elementary School.
