BE IT FURTHER RESOLVED, that the City Council hereby approves and authorizes the City Manager and the Corporation to take all actions necessary to amend the articles of incorporation and corporate bylaws to reflect the increased area of influence without the necessity for additional Council action

SUBJECT: STAFF SERVICES AGREEMENT WITH SOUTHEAST ECONOMIC
DEVELOPMENT CORPORATION: DESIGNATION OF SURVEY AREA

The following described area is designated as a survey area:

All the land in the City of San Diego generally bounded on the north by a line commencing at Highway 94 and Interstate 5 extending easterly along Highway 94 to Home Avenue then north on Home Avenue to the intersection of Federal Boulevard then easterly along Federal Boulevard to 49th Street then north along 49th Street to Elm Street then easterly along Elm Street to Euclid Avenue then north along Euclid Avenue to Westover Place then easterly along Westover Place to 54th Street then north northeast along 54th Street to Grape Street then east along Grape Street to Hampton Street then west along a line connecting Hampton Street with Westover Place then south along Westover Place to a line intersecting with Pentecost Street then south along Pentecost Street to the intersection of Federal Boulevard then easterly along Federal Boulevard to the intersection of Highway 94 then south southeast along Highway 94 to the intersection of Euclid Avenue then south along Euclid Avenue to the intersection of Market Street, east along Market Street to Merlin Drive, north along Merlin Drive to Brooklyn Avenue, then east along Brooklyn Avenue to 69th Street, then south along 69th Street to Imperial Avenue, then north along Imperial Avenue to the intersection of Foster Street, then east on Foster Street to Pidgeon Street, then south along Pidgeon Street to Jamacha Road, then west along Jamacha Road on an imaginary line to the intersection of Imperial Avenue, then westerly along Imperial Avenue to Euclid Avenue, then south along Euclid Avenue to boundary of City of San Diego and National City 01327 then westerly

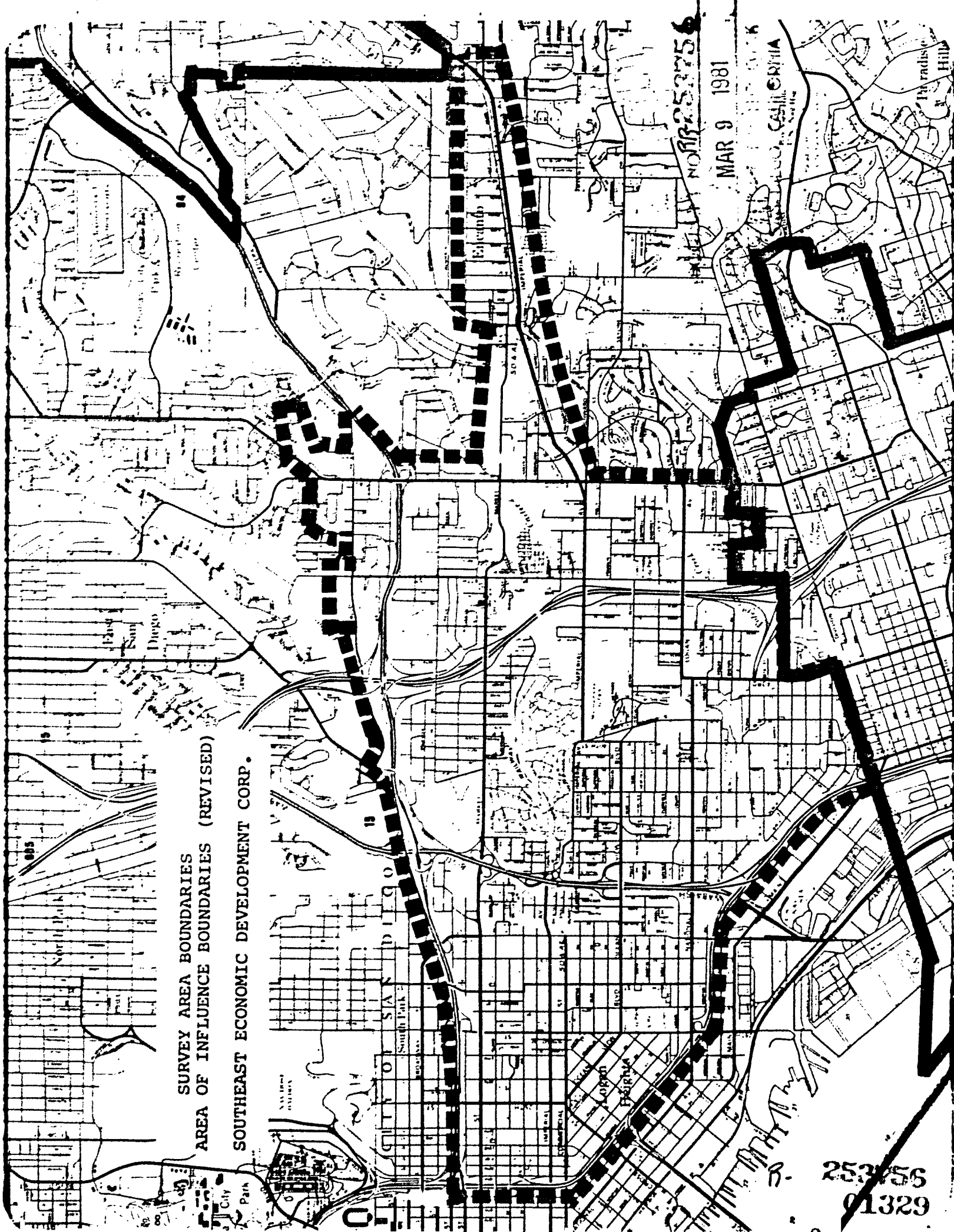

along same boundary to the intersection of Interstate 5 then north northeast along Interstate 5 to the intersection of Highway 94. Included in this survey area are the lands north of Federal Boulevard for a distance of approximately 100 yards from the intersection of Federal Boulevard and 45th Street east to 49th Street, the commercial strip area along the northwest side of 54th Street between Westover Place and Grape Street, all the area approximately 100 yards east of Euclid Avenue between Highway 94 and Market Street, all of the area approximately 100 yards north of Market Street between Euclid Avenue and Merlin Drive, all of the area approximately 100 yards south of Imperial Avenue between 69th Street and Euclid Avenue which boundaries are more particularly set forth in a document on file with the City Clerk as Document No. RR-253756
