RESOLUTION OF THE CITY OF SAN DIEGO APPROVING THE APPLICATION FOR 1980 STATE GRANT MONEYS.

WHEREAS, the people of the State of California have enacted the California Parklands Act of 1980, which provides funds to the State of California and its political subdivisions for acquiring lands and for developing facilities for public recreation and historical purposes; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of applications prior to submission of said applications to the state; and

WHEREAS, said applications contain assurances that the applicant must comply with; and

WHEREAS, the applicant agency will enter into an agreement with the State of California for the acquisition and/or development of the projects; NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego:

1. Approves the filing of an application for 1980 state grant assistance for the projects listed on Exhibit A,

attached; and

- 2. Certifies that said agency understands the assurances and certification in the application; and
- 3. Certifies that said agency has or will have sufficient funds to operate and maintain the projects; and
- 4. Certifies that said agency has reviewed and understands the General Provisions contained in the state/local agreement; and
- 5. Appoints the City Manager as agent of the City to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, payment requests, and so on which may be necessary for the completion of the aforementioned projects.

	Fiscal Impact - The total project cost of \$1,000,000 has been reduced by donations of \$131,000 from Bea Evenson and \$131,000 from the Committee of 100. Maintenance costs would be reduced when the renovation has been completed.			
2	Mission Bay - Beach and Restoration Work		396,602	
	Fiscal Impact - A reduction in maintenance costs would result.			
3	Highland-Landis Community Park and Recreation Center - Acquisition of adjoining property		417,602	
	Fiscal Impact - This acquisition will increase the size of the park by about 42% and includes buildings that are proposed to replace an existing undersize and over-age recreation building. Since the park and buildings would be larger, maintenance costs would increase about \$44,000 per year. Operating personnel would be transferred from the existing recreation building to the new building. Operation costs would increase an estimated \$11,000. Total project cost of \$1,300,000 is proposed for funding as follows: \$229,000 from CIP 29-271 Highland-Landis Community Park - Acquisition and Development; \$550,000 from CIP #20-027 - Vest Pocket Park; \$103,398 from future park fees; and \$417,602 from Proposition 1 funds.

	Fiscal Impact - There would be no change in maintenance costs with this project. With additional use, there would be an increase in operating cost.
