That the San Diego Housing Commission is hereby authorized to acquire the property at 3630 Van Dyke, the property at 4149, 4155-57 Chamoune, the property at 4390 Maple, and the property at 1399 Hollister for the construction of public housing for rental to low income families.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to release \$432,500 from the Fifth Community Development Block Grant entitlement year, Fund 18515, Dept. 5905, Org. 5908 (Low-Income Housing Site Acquisition Project), for purchasing the following sites:
