1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Agreement with WOODWARD-CLYDE CONSULTANTS, on file in the office of the City Clerk as Document No. R-253785 for an amount not to exceed \$82,000 to prepare plans, specifications and cost estimates for Sunset Cliffs Shoreline Protection Project approved by Resolution No. R-253784 adopted this date.

2. That the City Auditor is hereby authorized to transfer \$79,500 from C.I.P. 54-102, Black Mountain Road, to C.I.P. 13-002 Sunset Cliffs.

3. That the expenditure of \$82,000 is hereby authorized from C.I.P. 13-002, Sunset Cliffs, solely and exclusively for engineering design of the project.
