BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of CASE POWER AND EQUIPMENT is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of FOUR (4) 1981 MODEL CASE 580-C EXTENDAHOES WITH POWER SHUTTLE TRANSMISSION at a cost of \$27,260.00 each, for a total cost of \$109,040.00; terms net 30 days, plus sales tax, less trade-in allowance of \$17,000.00 each for four (4) Case 1979 580-C extendahoes with manual shuttle transmission.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$47,582.40 within Water Revenue Fund (41502) from Unallocated Reserve (70679) to Water Main Maintenance (705402).
