WHEREAS, Knotts Berry Farm of Buena Park, California, has donated a trolley car to San Diego for operation on the Gaslamp Quarter/Centre City Trolley Line; and

WHEREAS, Mr. L. J. Cella has offered to donate the sum of \$5,000 for the purpose of relocating and rehabilitating the trolley; and

WHEREAS, the trolley requires rehabilitation to make it compatible with the Trolley Line operation in San Diego; and

WHEREAS, said improvements require the expenditure of a significant sum of money; and

WHEREAS, the Gaslamp Quarter Association has proposed to move the trolley to San Diego, make improvements to the trolley to render it operational, maintain and safeguard it, all at a cost of \$5,000 and turn it over to the Trolley Line when said Trolley Line becomes operational; and

WHEREAS, the donation is offered to the City to defray the costs of relocation and rehabilitation by the Gaslamp Quarter Association; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that this Council, for and on behalf of itself and all the citizens of San Diego, does hereby acknowledge and accept the generous gift of \$5,000 from Mr. L. J. Cella and publicly extend to Mr. Cella a declaration of gratitude for that act of civic generosity.
