

1. That the City Auditor and Comptroller is authorized to transfer the amount of \$50,000.00 from Community Development Block Grant Fund 18516, Dept. 5965, Org. 6511 (CDBG 1980 South Chollas Creek Flood Control III-B) to CDBG Fund 18516, Dept. 5965, Org. 6518 (South Chollas Creek Flood Channel - Phase I).

2. That the above amount may be expended for payment of settlement costs for the acquisition of the two parcels of property which are the subject of the eminent domain proceeding entitled City of San Diego v. Ronald W. Argall, et al., San Diego Superior Court Case No. 437161.


