BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby directed to retain in the Community Concourse Acquisition Fund the \$1,750,000 presently available in said Fund to be used solely for lease payments and for the June 30, 1982 purchase of the Administration Building.

BE IT FURTHER RESOLVED, that the expenditure of \$1,600,000 to exercise the buy back option on June 30, 1982 is hereby authorized and approved.
