

RESOLUTION No. R-253815 (R-81-1513)

Adopted on MAR 17 1981

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. CARLON METER COMPANY, 2. ROCKWELL INTERNATIONAL, 3. BADGER METER, INC., 4. NEPTUNE WATER METER COMPANY, 5. HERSEY PRODUCTS, INC. and 6. MUESCO CONTROLS, INC., M & C DIV. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of WATER METERS AND PARTS as may be required for a period of one (1) year beginning March 1, 1981 through February 28, 1982 per prices on file in the Purchasing Department as follows:

1. CARLON METER COMPANY for Schedule I, Items 1, 2, 3, 4 and 6 and for parts for Carlon meters; terms net 30 days, plus sales tax and applicable freight charges, with an option to renew contract for an additional one (1) year period at prices not to exceed 14% of bid prices.
2. ROCKWELL INTERNATIONAL for Schedule I, Item 5 and Schedule III, Item 2 and for parts for Rockwell meters; terms net 30 days, plus sales tax and applicable freight charges, with an option to renew contract for an additional one (1) year period at prices not to exceed 10% of bid prices.
3. BADGER METER, INC. for Schedule II, Items 1, 3 and 6 and Schedule III, Items 1 and 3 and parts for Badger meters; terms net 30 days, plus sales tax and applicable freight charges, with an option to renew contract for an additional one (1) year period at prices not to exceed 5.5% of bid prices.
4. NEPTUNE WATER METER COMPANY for Schedule II, Items 2 and 4 and parts for Neptune meters; terms net 30 days, plus sales tax and applicable freight charges, with an option to renew contract for an additional one (1) year period at prices not to exceed 9% of bid prices.
5. HERSEY PRODUCTS, INC. for Schedule II, Item 5 and Schedule IV, Items 1 and 2 and parts for Hersey meters; terms net 30 days, plus sales tax, plus applicable freight charges.
6. MUESCO CONTROLS, INC., M & C DIV. for parts for various water meters; terms net 30 days, plus sales tax.
