BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$323,550.00 from CIP 52-243, Fund Nos. 18511, 18512, 18513, 18514 and 18515, and \$8,350.00 from CIP 58-007, Fund 30245 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
