PHELPS, a Registered Civil Engineer, entitled "CARROLL INDUSTRIAL LTD., Being a subdivision of Lot 1 of Crest Mar Park, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 8802, filed in the office of the County Recorder of San Diego County, February 15, 1978, excepting therefrom all oil, gas, asphaltum and other hydrocarbon substances as reserved by Spreckles Holding Company, Ltd. in deed recorded April 19, 1949, as Document No. 34775 in Book 3175, Page 222 of Official Records., is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOVLED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for general utility purposes over, under, upon and across Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said
