

RESOLUTION No. R-253844 (R-81-1616)


Adopted on MAR 23 1981

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a portion of Pueblo Lot 1294, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the office of the County Recorder of said County, November 14, 1921, and is known as miscellaneous Map No. 36, as more particularly described in the document attached hereto as Exhibit A and incorporated herein, is hereby set aside and dedicated as and for a public street, and the same is hereby named BERINO COURT.

That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.

LEGAL DESCRIPTION

All that portion of Pueblo Lot 1294 of the Pueblo Lands of San Diego according to Map Thereof made by James Pasco in 1870, a certified copy of which was recorded November 14, 1921, in the Office of the County Recorder of San Diego County, State of California as Miscellaneous Map No. 36 as more particularly described as follows:

Beginning at the Northeast corner of Genesee Highlands Unit No. 6 according to Map thereof No. 7179, filed in said Office of the County Recorder of San Diego County said corner also being the northerly line of Berino Court as described in Deed to the City of San Diego on July 25, 1978 at File/Page No. 311930 as filed in said County Recorder's Office; thence along said northerly line S87°06'59"E, 34.06 feet to a point on the arc of a 45 foot radius curve, concave southwesterly, thence northwesterly and westerly along the arc of said curve, through a central angle of 84°42'13", an arc distance of 66.53 feet to a point to which a radial bears N25°44'51W said point also being the point of a reverse tangent 20 foot curve concave northwesterly, thence westerly along the arc of said 20 foot radius curve, through a central angle of 48°23'39', an arc distance of 16.89 feet, to a point to which a radial bears S22°38'48"W; being also a point on said northerly line of Berino Court, and also a point on the arc of a 600 foot radius curve, concave northeasterly; thence southeasterly along said northerly line of Berino Court, and along the arc of said curve, through a central angle of 30°36'29", an arc distance of 37.78 feet, to the Point of Beginning.
