That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ATCHISON, TOPEKA AND SANTA FE RAILROAD COMPANY for a crossing at Fifth Avenue, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253848.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer the sum of \$75,373 from Fund 30245 CIP 52-255, SA-680, to CIP 52-203.1, Harbor Drive.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$75,373 is hereby authorized from CIP 52-203.1, Fund 30245, for the sole and exclusive purpose of providing funds for this project.
