BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a cooperative agreement with the STATE OF CALIFORNIA for the engineering and construction costs associated with rehabilitation of the Cabrillo Bridge, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253849.

BE IT FURTHER RESOLVED, that the expenditure of sums not to exceed \$325,300 from CIP 53-031 (Cabrillo Bridge) and \$37,400 from CIP 73-083 (Main Replacements) is hereby authorized for the sole and exclusive purpose of providing funds for this project and related costs.
