BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer \$18,000 from CDBG fund 18516, Department 5969, Organization 6903 (Barrio Logan Northern Industrial Park) to CDBG fund 18516, Department 5965, Organization 6516 (BECA) to fund the City's share of the cost of the proposed master plan.
