

RESOLUTION NO. R-253856

(R. 81-1637)
MAR 23 1981

WHEREAS, in 1979, the City Council adopted a zone system for the operation of Dial-a-Ride; and

WHEREAS, the City was divided into zones and a fare of 25 cents is charged per zone with a maximum of 50 cents for medical trips; and

WHEREAS, the State provides funds under the State Transportation Development Act on a 10-1 ratio, i.e., fare recovery must be 10 percent of the amount provided up to an established limit; and

WHEREAS, sufficient funds to meet matching State funding guidelines are not being realized from the existing fare structure; and

WHEREAS, a proposed increase to 50 cents for the first zone, leaving all other fare levels the same would enable Dial-a-Ride to recover sufficient fares to meet State requirements for the remainder of FY 1980-81; and

WHEREAS, if Dial-a-Ride continues its present level of operation, the proposed fair increase will be sufficient to meet State matching requirements for FY 1981-82; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to take

those steps necessary to amend the fare structure for the City's
Dial-a-Ride service by increasing the fare to 50 cents for the
first zone.
