A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED, BY ADDING PROJECT NO. 52-269, ENTITLED "ROUTE 52 (SANTO ROAD TO ROUTE 67)," TO THE FISCAL YEAR 1981 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS IN THE SUM OF \$120,000; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE COUNTY OF SAN DIEGO AND THE CITY OF SANTEE FOR ROUTE RELOCATION STUDIES, AND AN AGREEMENT WITH THE STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION (CALTRANS) FOR AIR QUALITY STUDIES; AND AUTHORIZE THE EXPENDITURE OF \$115,000 FOR THIS PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 2, subsection 29 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 00-15298-1, as amended, be and the same is hereby further amended by adding C.I.P. Project No. 52-269, Route 52 (Santo Road to Route 67), to the fiscal year 1981 C.I.P. Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$120,000 from C.I.P. 52-255 (SA-680) Fund 30245 to C.I.P. 52-269 (Route 52).

3. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with the COUNTY OF SAN DIEGO and the CITY OF SANTEE for route location studies and environmental analysis, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253860-1.

4. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION (CALTRANS) for air quality studies, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253860-2.

5. That the expenditure of a sum not to exceed \$115,000 is hereby authorized from C.I.P. 52-269 (Route 52) Fund for the purpose of providing funds for the abovementioned studies.
