APPROVING MAP OF CARROLL RIDGE UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "CARROLL RIDGE UNIT NO. 2 Being a subdivision of portions of the Southeast Quarter of the Northeast Quarter; and the Northwest Quarter of the Northeast Quarter; and the Southwest Quarter of the Northeast Quarter; and the Southeast Quarter of the Northwest Quarter all in Section 10, Township 15 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to Official Plat thereof together with portion of Carroll Road (R.S. 466) as closed & vacated to public use.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Carroll Road and Nancy Ridge Drive for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.


