

RESOLUTION NO. R-253868

(R. 81-1686)

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of CARROLL ROAD has been relocated by the approval on this date of the dedication of a revised alignment for CARROLL ROAD by the acceptance of the final map of the subdivision to be known as CARROLL RIDGE UNIT NO. 2; and


WHEREAS, those properties adjoining that portion of CARROLL ROAD to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the subdivision to be known as CARROLL RIDGE UNIT NO. 2; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of CARROLL ROAD, as more particularly shown on Drawing No. 15089-B on file in the office of the City Clerk as Document No. RR-253868 - 1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

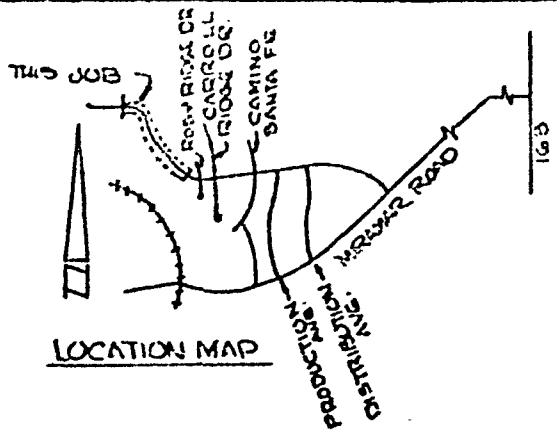

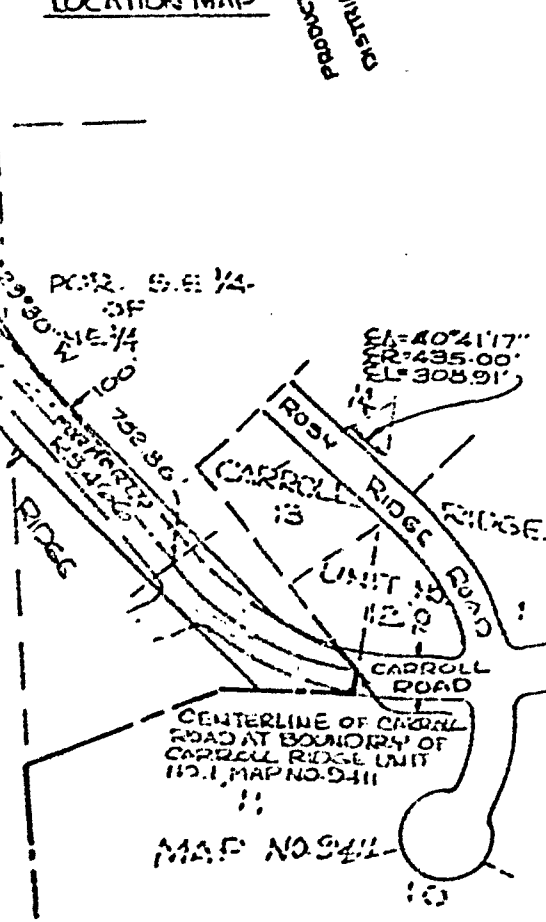
