Dennis L. Marnell	General Services	\$ 790	Mr. Marnell is an Equipment Mechanic in the Equipment Division. He suggested that the forward limit switches on refuse packers be relocated. This is expected to save \$5,269 in repair costs annually. This is a partial award pending a final 12-month review.
Daniel Fitterer	General Services	\$ 530	Mr. Fitterer is a Communications Technician in the Communications and Electrical Division. He suggested that crystals in portable radios be replaced rather than replacing the entire oscillator. This saved \$5,225 in equipment repair parts in one year of use.
