That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Jan E. Johnson	City Clerk	\$ 90	Ms. Johnson is an Intermediate Typist. She suggested that the format for Notices of Public Hearing for multiple actions on single parcels be revised. This is expected to save \$295 annually in processing costs.
Carl C. Copher James Froslic	General Services	\$ 75	One year ago Mr. Copher and Mr. Froslic earned a partial award of \$75 for their suggestion to install switches on refuse vehicles to prevent hydraulic pump overspeeding. One year's experience has shown a savings of \$1,500. This is the remainder of their award.
Gary W. Learn	Police	\$ 75	One year ago Mr. Learn earned a partial award of \$50 for his suggestion to implement a photography training program for Police Officers. One year's experience has shown a savings of \$1,225. This is the remainder of his award.
Gerry A. DeLaye	Park and Recreation	\$ 70	Mr. DeLaye was a District Recreation Supervisor at the time of his suggestion. He suggested that reminder signs to turn off lights be posted on switch plates. This is expected to save \$700 annually in energy costs.
Doris L. Plott	Building Inspection	\$ 65	Ms. Plott is an Intermediate Typist. She suggested that the phone-in meter release number be changed to improve processing time. This is expected to save \$212 annually.
