

RESOLUTION NO. R- 253876Adopted on MAR 24 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Wayne L. Ramsey	City Treasurer	\$ 60	Mr. Ramsey is a Supervising Field Representative. He suggested that Municipal Code Sections 33.3302 through 33.3312 be revised. This saves \$606 annually in administrative costs.
Donna J. Evans	Police	\$ 55	Ms. Evans is a Field Representative. She suggested that non-evidentiary identification be forwarded to NRC desks. This is expected to save \$1,083 annually in processing costs. This is a partial award pending a final 12-month review.
Ruth T. Nelson	Personnel	\$ 50	Ms. Nelson was an Assistant Personnel Analyst at the time of her suggestion. She suggested that transfer requests be approved by Certification personnel. This is expected to save \$515 annually in processing costs.
John M. Whyte	Fire	\$ 50	Mr. Whyte is a Fire Captain. He suggested that several first-aid cleanup techniques be implemented. Although savings could not be calculated, this was considered to be a significant safety improvement.
Florencia V. Santos	Building Inspection	\$ 25	Ms. Santos is an Intermediate Typist. She suggested that the CRT screen PMTOIU be revised to show compliance not verified. Savings could not be calculated, but this was considered to be a significant operational improvement.
