John M. Whyte	Fire	\$ 20	Mr. Whyte is a Captain. He suggested that a monthly master activity schedule be created. Savings could not be calculated, but this was considered to be a significant operational improvement.
Jan E. Johnson	City Clerk	\$ 20	Ms. Johnson is an Intermediate Typist. She suggested that the Hearing Officer use registered mail to notify applicants. Savings could not be calculated, but this was considered to be a significant operational improvement.
Robert F. Hutchison	Park and Recreation	\$ 20	Mr. Hutchinson is a Grounds Maintenance Worker II in the Coastal Division. He suggested that paint supplies be provided to pier custodians for minor touch up work. Savings could not be calculated, but this was considered to be a significant operational improvement.
James K. McCormick	General Services	\$ 15	Mr. McCormick is a Building Manager in the Buildings Division. He suggested that a flushometer be installed in the WOSK Building. This saves \$162 annually in water usage.
