BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the installation of low-pressure sodium street lighting systems on Linda Vista Road at Stalmer Street (two); Highland Valley Road and Pomerado Road (two); Carroll Canyon Road and Maya Linda Road (one); Evening Way and Gilman Drive (two); and Evening Way east of Gilman Drive in the Cul de Sac, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

BE IT FURTHER RESOLVED, that the expenditure of \$30,000 is hereby authorized from Capital Outlay Fund 30245 (CIP 52-293) Installation of City-Owned Street Lights," for the sole and exclusive purpose of providing funds for this project and related costs.
