A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED, BY ADDING PROJECT NO. 37-401, ENTITLED *REHABILITATION OF COMMUNITY CONCOURSE PARKADE ELEVATORS, TO THE FISCAL YEAR 1981 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS IN THE SUM OF \$330,000; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER EXCESS BUDGETED FUNDS TO THE APPROPRIATE RESERVES; AND AUTHORIZING EXPENDITURE OF \$30,000 FOR THIS PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- That pursuant to Section 2, subsection 29 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 00-15298-1, as amended, be and the same is hereby further amended by adding C.I.P. Project No. 37-401 (Rehabilitation of Community Concourse Parkade Elevators), to the fiscal year 1981 C.I.P. Program.
- 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$330,000 from C.I.P. 37.055.4, (West Miramar Sanitary Fill-Development) to C.I.P. 37-401 (Rehabilitation of Community Concourse Parkade Elevators).
- 3. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

4. That the expenditure of a sum not to exceed \$30,000 is hereby authorized from Capital Outlay Fund 30245 CIP 37-401 for the purpose of Construction Planning, Design and Inspection by the City's elevator consultant under the terms and conditions of the contract on file in the office of the City Clerk as Document No. 759474.
