

RESOLUTION NO. R- 253896

(R-81-1653)

Adopted on MAR 24 1981

WHEREAS, the City of San Diego, herein called "City," the Redevelopment Agency, herein called "Agency," and the Unified Port District, herein called "Port District," desire to upgrade the drainage facilities in the Central Business District in conjunction with City, Agency and Port District projects; and

WHEREAS, upgrading said drainage facilities requires construction of an outfall drain system in Market Street from approximately Fourth Avenue on the east to San Diego Bay on the west, and whereas the City, the Agency and the Port District desire to proceed with construction of the Market Street outfall drain in two phases and to share in the costs thereof; and

WHEREAS, such sharing of costs assigns to the Agency a cost not to exceed \$245,000, and to the Port District a cost not to exceed \$517,000, for a Phase I improvement of the Market Street outfall drain extending from approximately India Street on the east to San Diego Bay on the west; and

WHEREAS, such sharing of costs assigns to the City an amount estimated at \$996,000 for a Phase I improvement of the Market Street outfall drain from approximately Fourth Avenue on the east to India Street on the west; and

WHEREAS, Agency and Port District desire to proceed with Phase I construction in September, 1981; and

WHEREAS, City intends to proceed with Phase II construction in Fiscal Year 1984 pending availability of funds and allocation thereof by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said

City, an agreement with the Agency and the Port District for construction of the Market Street outfall drain in accordance with the terms and conditions of that Agreement on file in the office of the City Clerk as Document No.
