BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by JOHN M. LEACH, a Registered Civil Engineer, entitled  
VILLA COLINA UNIT NO. 2 Being a subdivision of a portion  
of Parcel 3 and Parcel 4 of Parcel Map No. 8547 filed in  
the office of the County Recorder in the City of San Diego,  
County of San Diego, State of California, recorded March 19,  
1979., " is made in the manner and form prescribed by law  
and conforms to the surrounding surveys; that said map and  
the subdivision of land shown thereon is hereby approved  
and accepted; and said Council hereby accepts on behalf  
of the public Calle Mariselda for public purposes, and said  
street is hereby declared to be a public street and  
dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation,  
the easement for open space over, under, upon and across  
Lot 4, as granted and shown on said map and subject to the  
conditions set forth thereon.

The Clerk of said City is hereby authorized and directed  
to endorse upon said map, as and for the act of the Council,



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, TIERRASANTA NORTE, a California partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of VILLA COLINA UNIT NO. 2.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
