BE IT RESOLVED, By the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of J. W. JONES COMPANIES, INC., a California corporation, executed in favor of The City of San Diego, bearing date of November 14, 1980, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 253912, granting to said City an easement for public street purposes over, along and across that portion of Lot 50 of The Highlands, Map No. 284, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and Parcel A is hereby named RUFFNER STREET, and Parcel B is hereby named DAGGET STREET.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
