WHEREAS, Resolution No. R-251268 (February 25, 1980) MAR 31 1981 authorized the City Manager to enter into an agreement with Yellow Cab Company of San Diego, Inc., to provide supplemental transportation services to the City's Dial-a-Ride Program; and

WHEREAS, Yellow Cab was authorized to provide transportation for medical trips for elderly and disabled persons registered with the Dial-a-Ride Program; and

WHEREAS, the passenger pays fifty cents and the Dial-a-Ride Program subsidizes the remainder of the trip of 4 miles or less; and

WHEREAS, the program offers an alternative to Dial-a-Ride clientele, when the existing service cannot accommodate their medical transportation needs; and

WHEREAS, a significant number of passengers are therefore able to be transported without additional vehicle acquisition by Dial-a-Ride; and

WHEREAS, the expansion of the taxi service to a six (6) mile limit would allow those persons living in the areas of high service demand, such as North Park, East San Diego, and Southeast San Diego, access to facilities in the Center City Area; and

WHEREAS, the present four (4) mile limitation prohibits this; and

WHEREAS, in addition, Clairemont and Kearny Mesa residents will have access to Kaiser, Sharp and Veterans Hospitals and

the Ocean Beach/Point Loma Communities could reach the downtown clinics as well as University and Mercy Hospitals; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the distance limitation heretofore established at four (4) miles for the City's Dial-a-Ride taxicab supplemental program be extended to six (6) miles.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute for and on behalf of said City of San Diego a second amendment to the agreement with the Yellow Cab Company of San Diego, Inc., which is on file in the office of the City Clerk as Document No. RR-251268, dated February 25, 1980, as amended by Document No. RR-252434, dated August 12, 1980, amending paragraph 2 thereof to reflect said increase from four (4) to six (6) miles, pursuant to the terms of the Second Amendment to Agreement on file in the office of the City Clerk as Document No. RR-
