APPROVING THE AMENDMENT TO AGREEMENT #619.0BG 37-207 UNDER THE ROBERTI-Z'BERG URBAN OPEN SPACE AND RECREATION PROGRAM.

WHEREAS, the Legislature of the State of California has enacted the Roberti-Z'berg Urban Open Space and Recreation Program, which provides funds to certain political subdivisions of the State of California for acquiring lands and for developing facilities to meet urban recreation needs; and

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility for the administration of the program, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of applications prior to submission of said applications to the state; and

WHEREAS, said applications contain a certification that the applicant will comply with all federal, state, and local environmental, public health, relocation affirmative action, and clearing house requirements and all other appropriate codes, laws and regulations prior to the expenditure of the grant funds; and

WHEREAS, the projects applied for under this program must be of a high priority and satisfy the most urgent park and recreation

needs with emphasis on unmet needs in the most heavily populated areas; and

WHEREAS, the applicant has heretofore certified by Resolution No. 220519 of March 20, 1978, the approval of applications hereunder and compliance with all federal, state, and local environmental, public health, relocation, affirmative action, and clearing house requirements and all other appropriate codes, laws and regulations prior to the expenditure of grant funds; NOW THEREFORE;

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council be and hereby:

- 1. Approves the filing of an amendment to agreement #619.0BG
  37-207, as set out in Exhibit A attached hereto and incorporated
  herein by reference as fully as if set out at length, under the RobertiZ'berg Urban Open Space and Recreation Program; and
- 2. Certifies that said agency understands the general provisions of the agreement; and
- 3. Certifies that said agency has or will have sufficient funds to operate and maintain the projects funded under this program; and
- 4. Certifies that said agency has or will have available prior to commencement of any work on the projects included in this application matheing money from a nonstate source; and
- 5. Certifies that the projects included in this application conform to the recreation element of the applicable city or county general plan; and

- 6. Appoints the City Manager as agent of The City of San Diego to conduct all negotiations, execute and submit all documents includning but not limited to applications, agreements, amendments, payment requests, and so on which may be necessary for the compeltion of the aforementioned projects; and
- 7. Appoint City Attorney as legal counsel for said agency with authorization to sign the certification on page 1 of application.
