BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to maintain and add C.I.P. No. 21-110, BALBOA PARK NURSERY AND SERVICE YARD RELOCATION to the Fiscal Year 1981 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$40,000 from C.I.P. Project No. 90-245, Capital Outlay Fund Unallocated Reserve and \$50,000 from C.I.P. Project No. 20-001, Annual Allocation, Minor Improvements, Capital Outlay Fund No. 30245 to C.I.P. No. 21-110 Balboa Park Nursery and Service Yard Relocation.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BERRYMAN AND STEPHENSON, INC. for professional services for park projects of minor scope and for the Balboa Park Nursery and Service Yard Relocation, said agreement is on file in the office of the City Clerk as Document No. RR- 253939.

BE IT FURTHER RESOLVED, that the following expenditure from the Capital Outlay Fund 30245 of The City of San Diego, be hereby authorized solely and exclusively for the above-stated purpose: \$90,000 from C.I.P. No. 21-110 Balboa Park Nursery and Service Yard Relocation.
