

**RESOLUTION No. R-253986**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the report of the Fire Marshal showing the cost of Weed Abatement against each parcel of land in City Manager's Report No. 81-27 of January 29, 1981, be hereby confirmed as to the following parcels:

418-280-04, 05, 06

676-020-02, 03

356-380-35, 36

BE IT FURTHER RESOLVED, that the Fire Marshal is hereby authorized to bill the property owners for the cost of abatement as confirmed with the exception that the amounts designated in City Manager's Report No. 81-27 of January 29, 1981, as Administrative Cost and General City Overhead of 31% be hereby reduced to 15% and that all bills to property owners shall reflect such reduction.

BE IT FURTHER RESOLVED, that the charges will be reduced by one-half and that bills to property owners shall reflect such reduction for the following parcels:

418-280-04, 05, 06

676-020-02, 03

BE IT FURTHER RESOLVED, that the assessment on parcel No. 356-380-35, 36, is reduced to \$5,000 and the bill to the property owner shall reflect this reduction.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to forward a certified copy of this resolution together with a copy of said report to the office of the County Auditor on or before August 10, 1981.
