That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with CROCKER NATIONAL BANK, pursuant to which not to exceed \$250,000 of Community Development Block Grant funds shall be utilized to support a program of reduced interest loans for rehabilitation of buildings in the Gaslamp Quarter, under the terms and conditions set forth in that Commercial Rehabilitation Program Credit Agreement on file in the office of the City Clerk as Document No. RR-253964.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$250,000 in Community Development Block Grant 7th Year Funds (Fund #18517, Dept. #5987, Org. #8701) for the second phase of the loan program, is hereby authorized and approved.
