A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED, BY ADDING PROJECT NO. 39-050, ENTITLED "NAVAL HOSPITAL SITE," TO THE FISCAL YEAR 1981 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS IN THE SUM OF \$60,000; AND AUTHORIZING THE EXPENDITURE OF \$60,000 FOR THIS PROJECT. APR 6 1981


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That pursuant to Section 2, subsection 29 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 00-15298-1, as amended, be and the same is hereby further amended by adding C.I.P. Project No. 39-050 (Naval Hospital Site), to the fiscal year 1981 C.I.P. Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$60,000 from the Capital Outlay Unallocated Reserve (CIP 90-245) to CIP 39-050, Naval Hospital Site.

3. That the expenditure of a sum not to exceed \$60,000 is hereby authorized from C.I.P. 39-050 for the purpose of hiring appraisers to appraise the proposed Naval Hospital site and related properties in connection with the Condemnation action filed by the United States of America.
