2. That the transfer of \$133,950 from Park Fee Fund 11226 to T.O. CIP Project 29-261 is authorized.

3. That the expenditure of \$172,000 from Environmental Growth Fund 10505 and \$227,950 from Park Fee Fund 11226 for acquisition of this improved park site is authorized.

4. That the acceptance by the City Manager of the above referenced data is in conjunction with the settlement of San Diego Superior Court Case No. 444474, entitled City of San Diego v. Pardee Construction Company.
