BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Council acting for and on behalf of the San Diego Open Space Park Facilities District No. 1, having heard all protests against the acquisition of that property described in that Resolution of Intention No. R-253774 adopted by the City Council on MAR 16 1981, 1981, hereby overrules such protects and determines that the public interest and convenience requires the acquisition of said property for open space park purposes.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to acquire said property.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$1,475,000 as payment for said property and related costs from Environmental Growth Fund No. 10505 reserved for future bond issues, to be repaid from Open Space Park Facilities District No. 1 Bond Fund 79103, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deed to said property without further Council action.
