

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated is excess to the public's needs; and

WHEREAS, a portion of "B" Street between Seventh and Eighth Avenues; a portion of Seventh Avenue between "B" and "C" Streets; a portion of Eighth Avenue between "B" and "C", below grade elevation of 62.00 feet is excess right-of-way and not required for street or highway purposes; and

WHEREAS, there is no present or prospective use for the below grade right-of-way, either for public street purposes or for any other public use of a like nature; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, those properties adjoining those portions of "B" Street between Seventh and Eighth Avenues; a portion of Seventh Avenue between "B" and "C" Streets; a portion of Eighth Avenue between "B" and "C", below grade elevation of 62.00 feet, to be vacated will continue to have access; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the 0.047 acres of below grade elevation of 62.00 feet portions of "B" Street between Seventh and Eighth Avenues; a portion of Seventh Avenue between "B" and "C" Streets; and portion of Eighth Avenue between "B" and "C", as more particularly shown

on Drawing No. 15179-B on file in the office of the City Clerk as Document No. RR-253990, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

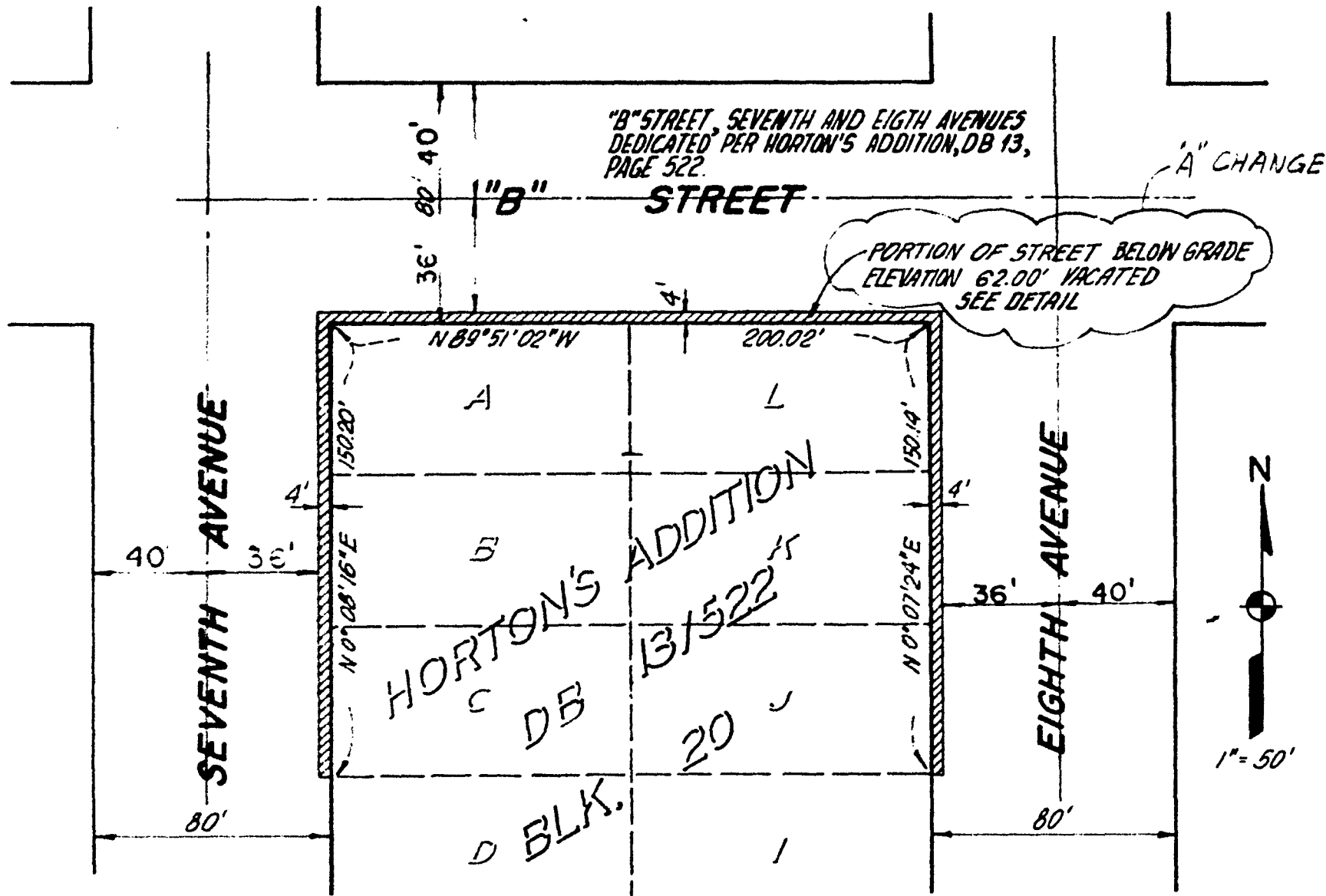
2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

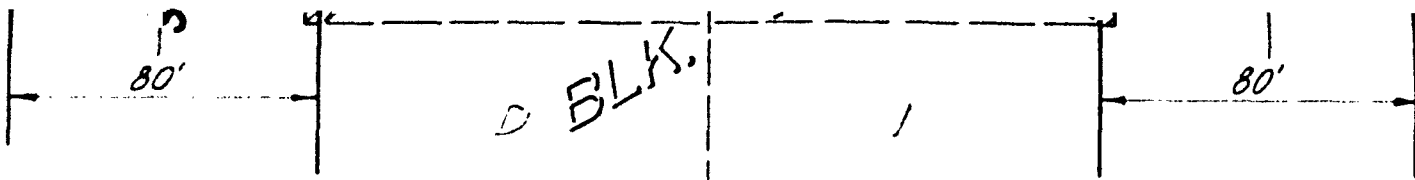

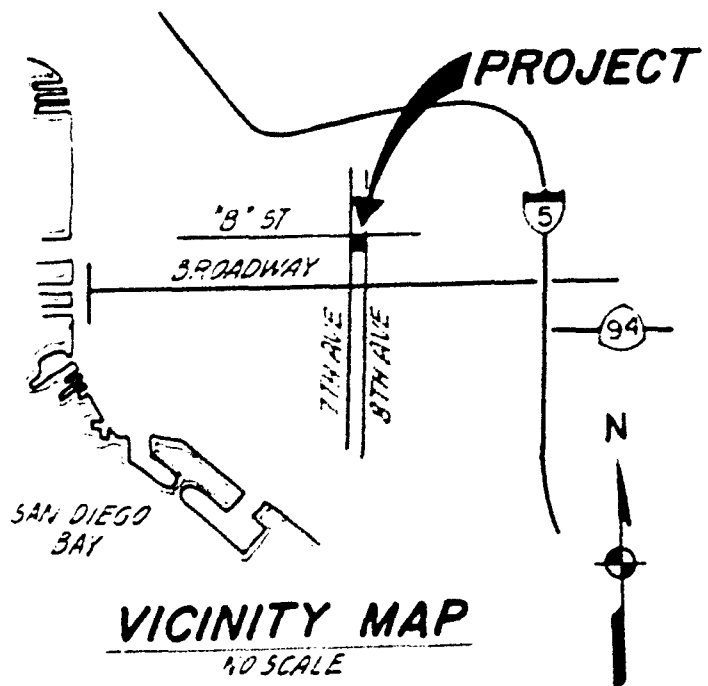


AREA OF VACATION: 0.047 ACRES

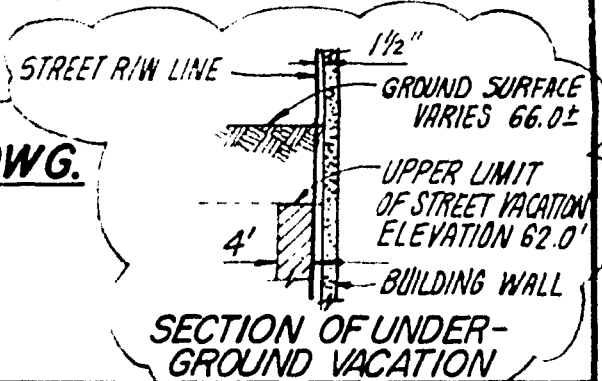
BASIS OF BEARINGS
