BE IT RESOLVED, By the Council of The City of San Diego as follows:

1. That the acceptance by the City Manager of that pedestrian and nonmotor vehicular and drainage easement deed of ALL VALLEY FINANCIAL CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date of January 5, 1981, a copy of which deed is on file in the Office of the City Clerk as Document No. RR-253991-1, granting to said City the permanent easement and right of way to construct, reconstruct, maintain, operate and repair a sidewalk in Parcel A and a storm drain in Parcel B in Lot 1 of Hughes Tract No. 1, according to Map thereof No. 9518, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed in Parcel A is hereby dedicated as and for public pedestrian and nonmotor vehicular purposes.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-253991-2, quitclaiming to ALL VALLEY FINANCIAL CORPORATION, all the City's right, title and interest in the drainage and retaining wall easement in Lot 1 of Hughes Tract No. 1, according to Map thereof No. 9518, as more particularly described in said deed.

3. That the City Clerk shall cause both deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
