BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with PRC TOUPS CORPORATION for engineering services for the design of flood protection facilities on South Las Chollas Creek from north of Ocean View Boulevard to 40th Street, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. R-253994.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer within Fund 18516 the sum of \$72,000 from Fund 6511 (South Chollas Creek Flood Control - Engineering Design and Construction - Phase III) to Fund 6505 (South Las Chollas Flood Control - Engineering Study - Phase III).

BE IT FURTHER RESOLVED, that the expenditure of \$97,000 is hereby authorized out of Fund 6505 (CIP 12-204) for the sole and exclusive purpose of providing funds for the above services.
