BACKGROUND

The San Diego General Plan Advisory Committee was appointed to advise, counsel and assist in the formulation of the San Diego City General Plan. That committee, in transmitting the plan to the City Council, recommended that "any federal urban renewal project or program considered by the City should be restricted to those projects and programs which are to be under public ownership, both immediate and permanent."

PURPOSE

It is the purpose of the City Council to encourage and to assist the proper conservation, rehabilitation and redevelopment efforts within the community. This policy is adopted to implement the recommendations of the General Plan Committee that applications for federal financial assistance with respect to urban renewal projects should be limited to those public projects, continuing ownership of which will be vested in a public agency, excluding, however, any public housing project.

POLICY

Applications by The City of San Diego for federal financial assistance in connection with an urban renewal project which involves acquisition of private property shall be limited to public projects, continuing ownership of which is vested in a public agency. Such assistance shall not be sought for any public housing project involving urban renewal.
