BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor be and he is hereby authorized to transfer within Sewer Revenue Fund 41506 the sum of \$726,538 from CIP 46-054, Sedimentation Basins 7 and 8, and \$800,000 from CIP 46-046.0, Scum Removal System, to CIP 46-071, Sewer Grant Contract 540, Construction for Headworks, Scum and Odor Removal, Gas Utilization, Electrical and Related Equipment Purchases \$1,116,145, and to the Unallocated Reserve \$410,393.

BE IT FURTHER RESOLVED, that the additional expenditure of \$1,116,145 is hereby authorized for executing contracts and related costs for CIP 46-071, Construction Contracts C-2, C-3, C-4, C-5 and Equipment Purchase Contracts E-3, E-4, E-7, E-10, E-11, E-12 and E-13.
