

RESOLUTION No. R-254013 (R-81-1769)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. HERTZ EQUIPMENT RENTALS, 2. NATIONAL EQUIPMENT RENTAL, 3. RAM ROD RENTALS, 4. HAWTHORNE RENT IT SERVICE, 5. CALIFORNIA CRANE AND RIGGING SERVICE, 6. E.A. RUTLEDGE, INC., 7. ANDERSON DRILLING, 8. BOB'S GRADALL, 9. THE TOOLSHED, INC., 10. PENHALL COMPANY, 11.
