That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said city, an Agreement with ATKINSON, JOHNSON & SPURRIER, a California corporation, to provide Phase I engineering services in connection with the improvement of Sorrento Valley Road from Sorrento Valley Boulevard to 3,300 feet northerly, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-254065.

BE IT FURTHER RESOLVED, that the expenditure of \$104,000 is hereby authorized from CIP 52-099.4, "Sorrento Valley Road-Sorrento Valley Boulevard to 3,300 feet Northerly," solely and exclusively for this project.
