Maureen Whelan Paul Michalek	General Services	\$1,900	Ms. Whelan is a Senior Clerk, and Mr. Michalek is a Building Services Supervisor in the Buildings Division. They suggested that outgoing U. S. mail be presorted by zip code. This is expected to save \$12,674 in postage costs in the first year of use. This is a partial award pending a final 12-month review.
Jonathan T. Harker Joe A. Rametta	Engineering and Development	\$ 500	Mr. Harker is an Engineering Trainee, and Mr. Rametta is a Junior Engineering Aid. They suggested that self-compensating air switches be installed in traffic counters. This is expected to save \$3,556 annually in preparation and maintenance time for traffic surveys. This is a partial award pending a final 12-month review.
