

RESOLUTION NO. R- 254078Adopted on APR 28 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Eldon D. Smith	Police	\$ 325	Mr. Smith is a Sergeant. One year ago he earned a partial award of \$290 for his suggestion to simplify the procedure for voiding and dismissing citations. One year's experience has shown a total savings of \$6,157. This is the remainder of his award.
Guthrie Riley	General Services	\$ 250	Mr. Riley is an Airport Operations Assistant in the Airports Division. He suggested that the transient parking at Brown Field be realigned. This is expected to produce an additional \$7,100 in revenue annually. This is a partial award pending a final 12-month review.
Nathaniel W. Kaufman	Police	\$ 230	Mr. Kaufman is a Sergeant. He suggested that extra copies of crime cases be eliminated. This is expected to save \$1,519 annually in copying costs. This is a partial award pending a final 12-month review.
Rae Ann Harper	Police	\$ 210	Ms. Harper is an Intermediate Typist. She suggested a revised filing system for moving citations and traffic warnings. This is expected to save \$1,410 annually in processing time. This is a partial award pending a final 12-month review.
Daniel Karsh	Police	\$ 180	Mr. Karsh is a Sergeant. He suggested that draft responses to citizen complaints made by Police personnel be eliminated. This saves an estimated \$599 annually.
