WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Florencia V. Santos	Building Inspection	\$ 135	Ms. Santos is an Intermediate Typist. She suggested that Form IN-1779 be revised to be a one-sided form. This saves an estimated \$450 annually in printing and microfilming costs.
Edna Gonzales	Police	\$ 130	Ms. Gonzales is an Intermediate Typist. One year ago she earned a \$90 award for her suggestion to eliminate an internal Police Department telephone log. First year's savings were \$2,177. This is the remainder of her award.
Robert P. Cruz	Police	\$ 80	Mr. Cruz is a Police Officer II. He suggested that the procedure for reporting accidents with minor damage and no repairs required be simplified. This is expected to save \$259 annually in processing costs.
Diane P. Gould	Water Utilities	\$ 75	Ms. Gould is a Senior Clerk in the Services Division. She suggested that fewer copies of Council Committee agendas be made in the Services Division. This is expected to save \$257 annually.
Robert C. Nightingale	Planning	\$ 60	Mr. Nightingale is a Zoning Representative. He suggested that hill-side permit numbers be eliminated on zoning maps. This is expected to save \$1,132 annually in processing costs. This is a partial award pending a final 12-month review.
