WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| <u>NAME</u> | <u>DEPARTMENT</u> | <u>AMOUNT</u> | <u>SUGGESTION</u> |
|-----------------------|---------------------|---------------|---|
| Robert C. Nightingale | Planning | \$ 55 | Mr. Nightingale is a Zoning Representative. He suggested that the process for issuing Home Occupation Permits be revised. Estimated annual savings in processing costs are \$545. |
| Ronald D. Willimann | Fire | \$ 50 | Mr. Willimann was a Fire Fighter at the time of his suggestion. He suggested that the engineer training program be revised. Although savings could not be calculated, this was considered to be a significant operational improvement. |
| Barbara Center-Amy | Building Inspection | \$ 20 | Ms. Center-Amy is a Senior Typist. She suggested that sign permit files be consolidated. Although savings could not be calculated, this was considered to be a significant operational improvement. |
| Rufino Yaptangco | Police | \$ 20 | Mr. Yaptanco is a Police Officer II. He suggested that consoles be used to install radios in undercover vehicles. This is expected to save \$243 annually in installation and maintenance costs. This is a partial award pending a final 12-month review. |
| Delorese J. Shafer | Risk Management | \$ 15 | Ms. Shafer is an Intermediate Typist. One year ago she earned a \$40 award for her suggestion to revise the quarterly suggestion report files. One year's experience has shown a savings of \$546. This is the remainder of her award. |
