That the proposal of N/S CORPORATION is hereby accepted, and the City Manager is hereby authorized to execute a contract for the LEASE/PURCHASE OF THREE (3) AUTOMATIC CAR WASHES as may be required for the period of one (1) year beginning June 1, 1981 through May 30, 1982 at a cost of \$503.00 each for the month of June and a monthly cost of \$580.00 each for the remaining 11 months; terms net monthly in advance, plus sales tax; erection fee of \$1,500.00 each and freight charge of \$250.00 each with an option to renew contract for four (4) additional one (1) year periods and an option to purchase equipment anytime during the lease period. Contract cancellable at the end of each fiscal year.
